The California Department of Housing and Community Development (Department) is pleased to inform you that funds from the Housing Navigators Program (HNP) totaling \$221,210 have been awarded in your district. This program was funded in the 2019-20 Budget Act.

The Housing Navigators Program provides funding to counties for the support of housing navigators to help young adults, between the ages of 18 and 21, to secure and maintain housing, with priority given to young adults in the foster care system. The county may use the funding to provide housing navigation services directly or through a contract with other housing assistance programs in the county. Counties are encouraged to coordinate with the local Continuum of Care to foster communication and collaboration.

The Department is working diligently to create strong, healthy, and resilient communities with affordable housing throughout California. We look forward to continued collaboration with our legislative partners. A fact sheet with information about the Housing Navigators Program awards is enclosed.
